

President Trump spoke with FoxNews after the second attempt on his life...

Training and planning go a long way to successfully navigating the aftermath of using force

BOCH: Post use-of-force interactions

America's man-card doesn't imbue holders with knowledge about what to do in the aftermath of a use-of-force incident. In fact, a whole lot of concealed carry classes don't spend much time on it either, other than the obligatory, "I wanna talk to my attorney before I answer questions" routine.

Long-time instructor and student of the art of personal defense John Boch shared some strategies for just such a scenario at our Mattoon meeting in September.

He began by cautioning folks that just because they have a gun doesn't mean they need to engage with bad actors, especially in third-party defense. Avoidance is best. And sometimes retreat is the best option, especially if you have youngsters with you - or if you left your gun in the car or at home.

But if things do go down and you can't avoid the use of force, especially deadly force, what do you do? What do you say?

First up, if your situational awareness discerns bad things going down, get behind cover if you're not leaving out the back or elsewhere. If you do eventually decide to let your Roscoe do your talking, don't feel obligated to issue a verbal warning of any form. Let surprise work in your favor.

After shots ring out, Boch suggested putting on your big boy (or girl) pants and using your command voice if others are nearby. "STAY BACK, STAY BACK! HE'S STILL ARMED. LOOK AROUND! IS ANYONE ELSE HURT?"

As a good guy with a gun, you *must* break the

tunnel vision to assess for additional threats. Not just bad guys, but other concealed carry holders who might want to play the hero, as well as off-duty cops.

When people start looking towards you, use your non-dominant hand to point at them (with your finger, not your gun) as you make eye contact. "YOU, YOU and YOU. Call 911. Tell them we need police, an ambulance and I need backup. Do it now, please!" Please is optional. Those calls are your outer ring of safety.

Don't answer any questions. Keep your situational awareness on high alert. As cops are enroute, send someone out to greet the cops, ideally an employee. That's your middle ring of safety.

Lastly, holster up and have your hands in the air if at all possible as police move closer. Your own non-threatening behavior is your inner ring of safety as responding officers take control of the scene.



Expect to get cuffed then questioned. If you can remember to identify the bad guy and let the cops know you'll cooperate with his prosecution if he lives, great. If you can remem-

ber to point out the evidence and describe any fellow bad guys who might have fled, even better. Point out the witnesses. Then ask to speak to your attorney before answering any questions.

Then shut your mouth.



If you can't remember the above rap, then ask for an attorney before you answer any questions. Resist the temptation to say anything more. To anyone. Bodycams will record *everything*.

Feeling ill at having shot down a fellow human being? Ask for an ambo ride to the ER to get checked out. Don't lie and tell them you're feeling like you're having a heart attack (that lie will get used against you later, by the way). Just describe your symptoms and ask for an ambulance ride. Share minimal details outside of medical information with paramedics and hospital staff. Remember, they write reports too.

Hopefully you've got a top tier legal team already in your back pocket. If you have legal insurance, that "insurer" will pay for your legal representation, along with expert witnesses. That will eliminate your anxiety about paying a six-figure bill for a world-class legal defense.

If you don't have an insurance policy or crimi-

nal defense firm in mind, now's a swell time to remedy both. Ask your cop friends who they would hire if their spouse shot some mope outside Walmart. Call that firm, spend a couple hundred bucks for a short consult and if you like them, get an emergency number or cell phone of one of their lawyers.

Get in touch with your preferred legal defense company and spend some bucks to get enrolled and protected. Armed Citizens Legal Defense Network, USCCA and US Law Shield are three of the very best. There might be others that better suit your needs. Just pick one and sign up.

Don't talk with friends and family about what happened. Anything you say to anyone outside of your spouse and your legal team is discoverable to the prosecution. Find a distant friend if you have to vent - a friend who can keep his or her mouth shut.

By the same token, if you have a friend who is involved in something like this, don't ask for details. Just let them know you're glad they survived. Give them a hug. Tell them you're there for them and ask if you can bring them some dinner or watch the kids and/or pets while they enjoy some alone time if that would help.

As for the media? Don't. "No comment." No matter how good lookin' that reporter or reporterette they send to knock on your door to interview you might seem, or how sweet they talk, don't speak with them. They're in the business to sell stories and clicks. Sensationalism sells. Bad guy getting his just desserts does not. They're not going to cast you and your use of force in a favorable light. Nobody's gonna give you the key to the city.

There's more, but you get the idea. Avoidance beats dealing with all this mess. And good situational awareness will help you avoid a whole lot of bad things in life.

Because crime never happens on mass transit, especially in Chicago

Guns on public transportation case opens door to ending Illinois "gun free" zones on mass transit

Chicago (CBS) -- A federal judge ruled the Illinois law banning people with concealed carry permits from taking guns on public transportation is in violation of the Second Amendment.



Four people filed a federal lawsuit in 2022 because they couldn't take a concealed firearm on the CTA or Metra. They claimed it violated their right to selfdefense, and as a result they didn't use public transportation as much as they would have liked.

In a ruling on Friday, U.S. District Judge Iain Johnston ruled that Illinois' ban on carrying concealed weapons on public transit does not meet the U.S. Supreme Court standard set out in its June 2022 ruling in the case known as New York State Rifle and Pistol Association v.

[Editor: This is an "as applied" challenge, and as such applies only to the four plaintiffs. However it does lay the groundwork for a later "facial" challenge to strike the prohibition altogether. Whether or not this decision survives the Seventh Circuit Court of Appeals is another matter.]

CTA rail workers demanding action on safety front

(The Center Square) - Chicago activist Tio Hardiman is urging CTA rail workers to come together in their battle with management aimed at keeping them safe and protected while on the job.

Over the last two weeks, at least five people have been shot, four of them fatally, on or near the rail system, leaving many workers and riders alike shaken and traumatized by the thought of boarding a CTA train.

NO CASH BAIL ONE YEAR ANNIVERSARY

LEGACY MEDIA: A year after end of cash bail, early research shows impact less than many hoped or feared

Springfield (Capitol News Illinois) - One year after IIlinois became the first state in the nation to eliminate the use of cash bail, the impact on the state's criminal justice system appears to have been far less dramatic than people on either side of the debate had predicted.

That, at least, is the early indication from an analysis of data being monitored

by the Center for Criminal Justice at Loyola University in Chicago.

"Jail populations did go down a bit, but nowhere near as much as some people were predicting, and the research suggests that the rate at which people are being released from jail pretrial likely hasn't changed dramatically," David Olson, a co-director of the center,

said during an interview this week.

"What's changing is that the means of release are changing," he added. "People don't have to post the money, and rather than being released in a few days when they come up with the money, they're being released in a day or

ALTERNATIVE MEDIA: In Chicago, nearly 20% of felony arrests are people already out 'No Cash Bail' from other arrests, up from 8.5% under old system

Chicago (CWB Chicago) - Nearly 20% of people arrested and charged with felonies in Chicago are already on pretrial release for another pending criminal case, a number that appears to be substantially higher than during a comparable period last summer, when Illinois still operated on a cash bail system.

That's one finding from a deep dive that CWBChicago conducted into Cook

County court records as the state approaches the one-year anniversary of the cashless bail era.



How does that compare to the cash bail era? To find out, we dusted off copies of Central Bond Court manifests maintained by attornevs from the Law Office of the Cook County Public Defender during July and August last year.

Those documents showed that only 8.5% of defendants facing new felony charges were noted as being in violation of bail bond.

Democrat running for Cook County State's Attorney:

'We don't need no free speech!'

The mission statement goes on to read their staff is there to "vigorously prosecute crimes committed in the county".

It is the State's Attorney's role to prosecute violations of the criminal law while respecting the Constitutional rights of the accused and the public at large. They even take an oath to that effect!

With that in mind, many find it shocking that Eileen O'Neill Burke, the Democrat running for Cook County State's Attorney has touted her mission to create a "Choice Protection

And as the Democrat candidate in a deeply Democrat county, she's pretty much assured to win - the only question is will it be with a 40% margin or 60% margin?

The Choice Protection Unit (CPU) will be specially trained and ready to launch actions ranging from civil actions to pursuing "municipal ordinance violations" and even misdemeanor and felony charges against those oppose to abortion services across

The fear is that the CPU will chill the free speech rights of people throughout Illinois. Instead of prosecuting bad conduct, Burke's CPU will work to prosecute what it considers "bad speech" - including lawful protests.

In Eileen O'Neill Burke's bizarro weird world, curtailing and prosecuting protected First Amendment speech is justified if it's for the greater good.

Fortunately courts disagree.

Maybe, just maybe the Cook County State's Attorney should endeavor to prosecute violent criminals while recognizing and respecting everyone's Constitutional Rights.

Maybe instead of creating the "Choice Protection Unit", Ms. Burke should review the current data on how almost 20% of those arrested on felony charges in Chicago were released without bail on previous arrests. That is up sharply from about 8.5% of arrestees that were out on bail under the old "Cash Bail" system.

Federal court challenge PICA gun and magazine ban underway

(The Center Square) - The bench trial for the challenge to Illinois' gun and magazine ban continues in East St. Louis.

Illinois enacted a ban on semi-automatic firearms and magazines over certain capacities in January 2023. Lawsuits challenging the law in federal court went all the way up to the U.S. Supreme Court on preliminary grounds. Justices denied the request, saying they wanted a full case on final judgment.

Monday began the trial to get to final judgment in the courtroom of federal Judge Stephen McGlynn.

Armory, was the first to testify for the plaintiffs.

"Plaintiffs would love to show that people use these for all kinds of lawful purposes," Pulaski said after testifying "The defense would love to show that it's not even fit for anything other than self defense and is more of a military firearm that's not suitable for personal protection or defense."

Pulaski said as a firearms dealer, they've lost up to 30 percent of their business because of the ban.

Plaintiffs argue the state can't ban commonly owned

> Eby said he recommends an AR-15 over a handgun or shotgun for home defense as the rifle has the best aim and ease of use.

The trial continues in the Southern District of Illinois federal court Tuesday.

TWO VIEWS ON POST USE-OF-FORCE INTERACTIONS WITH POLICE

Defense attorney Natalia Ogurkiewicz

STFU. DON'T TALK WITH THE POLICE.

We hosted Natalia Ogurkiewicz from the McDermott Law Group at our Pontiac GSL meeting in September. Her presentation wowed the audience and gave them an idea of what one might expect in the aftermath of a righteous use-of-force incident - at least when it comes to the inevitable interaction with the criminal justice system. Many of us carry a gun to make us harder to kill. Not so many of us know some things to do to make ourselves harder to convict afterwards.

We featured an in-depth report last month about Natalia and her rise from serving as a prosecutor under Kim Gardner in St. Louis before transitioning to criminal defense work for the McDermott Group out of Homewood, IL. They handle self-defense cases nationwide and have a well-deserved reputation for winning in court.

She lamented the increasing application of "headline first" prosecution of people who decades earlier might not have been charged. Racial considerations, politics and the legacy media all increasingly drive charging decisions towards prosecution today, especially for Team Soros prosecutors. Law-abiding folks pay the price for that.

She strongly recommended saying very little, if anything. Why? "They will twist anything you've said." With the advent of bodycams, those videos will even expose you to attacks based on not only what you say but how you said it. Were you mad? Angry? Vengeful? Flippant? When it comes to the police, say NOTHING after asking to speak to your attorney before answering questions.

Ogurkiewicz warned that you have to ask for an attorney for police questions to stop. Otherwise officers can continue to badger question you to elicit incriminating statements.

Furthermore, nothing you say can be used towards your exoneration in court - so there's

literally NO REASON to answer police questions or make any statements. Even if you think you're 100% above reproach for what you did (such as a defensive gun use in your home), do NOT talk with the police before you have your attorney present.

Choose your words carefully with medical personnel too if you're taken to the hospital. Their reports can be used against you as well. And there will likely be police accompanying you as well - with their bodycams running. So keep your pie-hole closed.

She recommended avoiding making the 911 call if at all possible. Let someone else call. So long as someone has called for help it's okay to go ahead and call your attorney, even before police arrive. If you have to call 911 yourself, she recommended just giving the address and then ask for emergency services and hang up. Yes, they'll call back. No, you don't have to answer. The 911 dispatchers are trained to gather information, and it's all recorded. And you and the jury will hear it again if things go to trial.

Avoiding jail costs big bucks.

If you have self-defense legal coverage you won't have to write big checks for your criminal defense attorneys. If you don't, then break out the checkbook. To hire a top tier firm like Team McDermott, expect them to ask for a \$50,000 retainer up front. What's more, \$100,000 in billing on a big criminal defense case is routine.

Good attorneys, if you have them ahead of time, can even help influence whether or not prosecutors move forward with charges prior to any arraignment hearings. In Illinois that's crucial as with "No Cash Bail," if you're held at arraignment, you're pretty much stuck in jail until trial. Expect that to take months. With self-defense legal coverage, with one phone call you can have your own criminal defense attorney or a recommended attorney on your case within minutes, not days or weeks. And you won't have to write a \$50,000 check for a retainer.

YOU SHOULD TELL POLICE SOMETHING ...

(GSL) - At GSL's Peoria meeting, Peoria County State's Attorney Jodi Hoos joined us to talk about her work prosecuting bad actors in Peoria County. She describes herself as a very pro-gun, pro-law-and-order prosecutor.

When asked on her advice for what a card carry good guy or gal should say to police in the aftermath of a righteous use-of-force incident, she offered her perspective. As one might imagine it was a little different than the top tier defense attorneys we've hosted in other cities.

"I'm not a defense attorney," she began. She suggested that common sense would dictate that someone using force in self-defense should at least tell officers in general terms what happened. For example, "He broke into my house" or "he was trying to rob me." You don't have to repeat it a hundred times as police bodycams will record your words. And you certainly don't have to answer a bunch of questions without your attorney's presence. But giving responding

officers at least some idea of what happened will help them make the right call on what to do with you.

Why else should you say at least something? Because if the perp isn't acting alone, his pals are going to have plenty to tell the cops about how their comrade was just minding his own business before you came along. And if cops only have one side of the story, they're going to have to act upon that.



On the flip side, there are cameras almost everywhere and if the victim acted lawfully then that footage will help exonerate them regardless of statements from the bad guy's buddies.


Hoos went on to say that police in Peoria County know she's not going to touch a self-defense use-of-force case, no matter the headlines a refusal to charge might bring. If it's clear-cut self-defense, police in Peoria County are probably not going to make any arrests of the good guy/gal. If they have any doubts, they can call the prosecutor on call, but most of the time responding police at legitimate self-defense incidents just make a report and forward it to her office.

Germany vows 'Knife Control' after ISIS refugee slashes throats at 'Diversity Festival'

(Gatestone Institute) - After laying a white rose at the site of the Diversity Festival slashing that left three dead and eight wounded, Chancellor Olaf Scholz promised rapid action would be taken against knives.

Right now, people in Germany can carry knives up to 4.7 inches long. The law will be modified so that they can only carry knives up to 2.4 inches long. No one appears to have considered the

possibility that Muslim terrorists on the way to killing as many infidels as possible might violate the law and carry a concealed knife of 4 inches or longer. Such thoughts are unthinkable.

There were 13,844 "knife crime" incidents in Germany in 2023, which the authorities are blaming on the existence of knives and not the perpetrators, who are reportedly mostly young Muslim men.

But locating the source of the problem is probably "not a very helpful insight," In the UK, people sharing such insights are being locked up even as Islamic terrorists are being freed.

The German government is more moderate than the Marxist lunatics at Whitehall. Prime Minister Keir Starmer and Justice Minister Shabana Mahmood, a supporter of Islamic terrorism, have decided to ruthlessly suppress all British opposition to mass migration with raids and prison sentences.







Chicago (National Review) - During the first eight months of 2024, Chicago police arrested hundreds of people and recovered hundreds of guns and nearly 30,000 shell casings in part because of alerts from their ShotSpotter gun-shot detection system, which far-left mayor Brandon Johnson intends to begin phasing out in just over a week.

Police also responded significantly faster to ShotSpotter alerts than 911 calls, according to a Chicago Police Department report released this week that provides a new analysis of ShotSpotter data from January 1 through August 31.

Check your emergency supplies!

by John Boch (GSL) - September marks National Preparedness Month. This should serve as the impetus for you to check your emergency gear. Inspect and test your batteries in everything battery powered - including (especially) your smoke and carbon monoxide detectors.

Check dates on food and medicines stored for unplanned disruptions and rotate in fresh materials. This goes for your fuels too.

Recently, I'll confess to a more lackadaisical attitude on my propane bottles. I

just assumed these will last a long time without a lot of baby-sitting. I learned firsthand they don't.

Of a couple of dozen bottles I kept stored for emergency cooking and some other incidental uses, less than four had any fuel remaining and even those were mostly empty. Granted I bought most of these pre-Y2k (remember that?), but finding them all empty caused my anxiety to spike. After all, it's kind of hard to cook and heat foods indoors if the natural gas stops flowing to our homes. Of course, I remedied this promptly.

So check your stuff. October is Fire Prevention
Month and as our former director and retired firefighter
Al Devlin always reminded
us: make sure you invert
each of your fire extinguishers a few times to listen for
the powder inside to break
loose from the bottom of
the pressure vessel. You
should do this at least every year, and for vehicle dry
chem extinguishers, every
month is better.

So take a few minutes to check your gear to ensure it's ready for emergencies.

Pocket Rockets

Olight Warrior X Pro, Warrior 3S & Fenix TK20R

My name is John and I'm a "flashaholic." As a kid I felt a lot of anxiety about darkness. Today I enjoy the night and darkness, in part thanks to tools which take away the darkness from those who would exploit it to victimize me or others.

In my world, flashlights get used many times each day to see things or find things as I don't have 18-year-old eyeballs anymore. And then there's the role they play in the use-of-force continuum.

In the 2010s, EagleTac products rode in my pockets, but they repeatedly failed with hard use. Sure, they had a "lifetime" warranty but you had to ship them to China or Taiwan to collect on that. Even then the "repaired" products came back less than marvelous.

Fast forward: I did some research and settled on a Fenix and an Olight. The Fenix did super well. And the Olight Warrior X, although a great light in most respects was just too much to carry in any pocket - even in 5.11s.

In 2022, I wrote a review of those two state-of-the-art lighting tools. After it, the fine folks at Olight contacted me and asked if I'd review a couple of their products if they provided them. "Sure," I said. Of course, they've hounded me for the review, as if having it for a week or two will give me a real sense of a light's utility and function in real life. These are hundred-plus dollar flashlights, after all. They represent "real" expenditures for working class folks and deserve more than a cursory evaluation.

Warrior Pro X3

They sent me the (very substantial) Warrior Pro X3. It sells for about \$120. Yup, it's still way too darn big for comfortable EDC pocket carry. I'm used to carrying capable lights, but nobody I know wants this much bulk clipped in their pocket, especially if you wear jeans. (Ahem, is that a flashlight in your pocket?) Ladies are not going to want to put this monster in their purses, either.

For a tote bag, tac vest (thinking police style) or as a rifle-mounted light (pressure switch about \$40), it's hair-on-fire brilliantly bright. Worth repeating: It cranks out an obnoxious amount of light in a very tight beam. If you need to light up something or someone a hundred (or even a couple of hundred) yards away - and do it well - this is your baby.

It has stood up well to use and abuse, as have my other Olights of the past, something EagleTacs can't say.

It runs on the massive 21700 lithium rechargeable battery and charging comes easy with the O-Light proprietary magnetic tail charger that's used for most O-light products.

Read on for one big, potentially deal-killing shortcoming it shares with the Warrior 3S.

Warrior 3S

The Warrior is a smaller diameter light better suited to everyday carry. It also has a wider beam better suited to general use. A soft touch on the rear switch gives you plenty of light (300 lumens) and a harder press gives an insane 2250 lumens. I've been happy with its performance with the exception that it's prone to sliding out of my back pocket even when "clipped" to my pocket. Swing with the kids or grandkids on a playground? Wrestle

around on the floor? Going on carnival rides? Bottom line: the Warrior 3S is an awfully nice light to leave behind on a playground.

But here's the biggest complaint, one that borders on a *deal-killer*. If you don't hold your momentary press long enough (about a second) you may enter into the "hard" on mode that requires a second press to extinguish the light. When this failure turn off happens, no matter what you're trying to do, the Olight *harshly resets* your OODA loop. That would be *no bueno* in a gun fight, both from the distraction angle and how lights act as bullet magnets.

Fenix TK20R. The first thing everyone notices is how the TK20 has two buttons on the tail cap, one large and one small. The small one gives instant access to a 3100 lumen strobe light. This is a "WHOA!" moment the first time you fire this up, especially indoors. It may disorient some aggressors and even allegedly cause seizures. I love having that option instantly available. Remember that use-of-force continuum thing?

The *much* larger button, with a light press serves a momentary activation switch. When conditions require a LOT of light, there's over 3000 lumens inside just waiting for you to set them free. A harder press gets you into a "hard" on/off mode. Loosen the front end of the light a smidgen and you get a more manageable, but still crazy bright reduced output.



Criticism: Yes, it's a little on the large side. It has some heft which can help with DNA core sampling while it dissuades attackers when judiciously applied to a bad guy's noggin, further assisted by the scalloped bezel.

Another criticism: In a small room with light colored walls, you'll blind everyone including yourself with light splashing back if you're not judicious in using it. Or in everyday carry use, if you press the wrong button by mistake, like in a dark restaurant trying to read the menu, you'll become the center of attention. In this case, your temporary blindness will preclude noticing annoyed looks from everyone in your section of the restaurant. Even from a distance it will also really screw with the pitcher in professional baseball games, even when not pointed at them. Ask me how I know. (It probably wouldn't help a kicker in an NFL game either.) Also, one almost needs two hands to switch brightness modes, but it's manageable.

I know a hundred-plus bucks for a flashlight represents big-time money for most of us regular peeps. It's real money. On the other hand, these are real lights, not the alkaline battery toy lights found in big box retail stores. If you have the coin and you don't mind a larger body flashlight, you likely won't be disappointed with the TK20R. You might even be dazzled with it. Literally - just like the kids today like to say. It has earned its spot as my primary carry light now.

As for the Olights: They're relegated to backup status for the time being. They're nice, but that switch problem nags at me.

And then there's the glass/electronics on top for sighting. That's readily available, and you might even find something calibrated for the new cartridge.



For now at least, kitting out and fielding one of these new rifles in a social conflict resolution configuration will remain the domain of the very wealthy and connected.

A fellow could easily equip a four-person squad with good rifles, great optics and oodles of mags and defensive ammo for the price of a single, well-dressed SPEAR. And probably still have room for dinner and maybe some armor too.


Shiny Brazilian RP-63 round butts Rossi's latest 6-shot .357 is affordable (\$350 street), reliable and shoots very nicely

(Shooting News Weekly) - Today we're going to review a Rossi - specifically the RP-63.

So why specifically are we reviewing a Rossi? Simple. Not everyone can afford a \$1,000+ wheel-gun.

That's where Rossi comes in. It's an affordable revolver for the working-class revolver



Times change, though, as we've all seen. The revolver market is undergoing a renaissance. And, thankfully, Taurus has dusted off the Rossi brand and they're back in the game, too.

As something of a revolver connoisseur, I was intrigued when I saw their round-butt 3-inch six-shot .357 Magnum chambered

What really impressed me was fact the fact that the new Rossi revolvers aren't just rebadged Taurus guns. These are their own new designs. Yes, there's a genetic linage to Taurus, but cracking a Rossi open, this isn't an updated Taurus. It's much closer to a traditional Smith & Wesson (which Taurus was too, back in the day) and that excited me.

The RP63 a clean design. It's literally what one would stereotypically thinks of when they think "revolver."

Anyways...Rossi's RP63 is pretty much everything that I think is just right for the revolver market at the moment. It's a sixshot .357 Magnum chambered round-butt revolver with a 3-inch barrel. It has a satin stainless finish with simple, but rugged fixed sights. It's the perfect no-frills carry gun for someone who's on a budget. And that's what led me to get one. I wanted to see if this was real and if the juice is worth the squeeze.

In short, it was. Sure it has some minor cosmetic issues but it runs. The gun thus far has been perfectly reliable and it's very affordable. I've seen them hovering around the \$350 retail price point. You can't get gun like this from S&W, Ruger, or Colt for that price. You can't even get a Taurus revolver in this configuration since their Model 605 is a five-shot revolver.

Again, for working class folks who want a concealable six-shot .357 Magnum revolver, the Rossi RP63 right now is the best bang for the buck. It's fifty-state legal and at its price point, the quality is more than there.

Onnais Iron SE Biometric gun safe

Store your firearms so they are inaccessible to unauthorized persons by John Boch

The NRA tells us to store our firearms so they are inaccessible to unauthorized persons. Yes, it's a shame that we need to secure our firearms in our homes and vehicles, but that's the world we live in today.

Having a lock box to secure an extra gun or two in your car is never a bad idea. It keeps the smash and grab artists from absconding with your Roscoe. It also secures your piece against some suburban PDs who reportedly like to walk the parking lots of high end venues looking for a guns plainly visible inside a car.

Formerly, I was a card-carrying member of the "gun under the seat" or "extra gun in the console" club. That was in the BC era - before children. My kiddos love guns now and while they know the rules, when it comes to guns I just don't trust them.



After a modest amount of research, I settled on the Onnais Iron SE biometric safe. \$60 from Onnais or \$66 from Amazon, or about half what I expected to pay for a "safe." It has key access, as well as a numeric code and fingerprint access. Honestly, I didn't have high hopes for the fingerprint feature but it has worked pretty well for me.

I remedied the only problem I had by adding "upside down" fingerprints so I had access no matter the orientation of the box. A quick touch, a reassuring soft beep (which can be silenced) and then it pops

It's secured by a cable that goes through the seat mounting bracket. Programming the access code and fingerprints went smoothly without issue once I put in a trio of AA batteries. Read the instruction card.

No, it's probably not bullet-proof nor tool resistant, but it will thwart most car burglars, especially the amateurs.

The metal boxes fit snugly under the front seats in my Explorer. Your mileage may

vary as far as fitting it under the seat in other makes and models of vehicles. You might measure first and order once.



It fits snug as a bug under my front seat.

If you do have a mid- to larger ride that will accommodate this particular unit, I would definitely give this biometric box two thumbs up.

Regardless of car size, this would make a nice storage box for the nightstand, under the bed or elsewhere for safe and secure storage in the home - or (gasp!) in the



I liked the first one so much I ordered two more: one for the wife's ride and a second one for me. Why two for me? Because I carry a spare gun in a carry rig, along with a flashlight and ammo in the car. That doesn't leave any room for my carry piece(s) when I visit my kids' school or go to the Post Office. Now, I have a place to secure my carry iron and I worry much less about a little punk stealing my piece or my kiddos or their friends finding it for

TIP: Secure your piece, out-of-sight, in your car

(GSL) - Going golfing and don't want to carry on the course or at places called "Topgolf"? Or stepping out of your car at a non-permissive environment and leaving your piece in the vehicle? Make darn sure you put it completely out of sight in your car.


Sure, plenty of those were bad guys who illegally had guns (and drugs... go figure) with them, but still it's a hassle you don't need even if you have your carry license.

Good Samaritan shoots man attempting to carjack mom and child

Falls Mill, VA (WVVA) - A Good Samaritan shot a wanted man attempting to carjack a woman and her child on Friday.

According to Major Harold Heatley with the Tazewell County Sheriff's Office, the incident happened at Lee's Kar-Go when the suspect, identified as Cody Dailey, 30, "attempted to carjack a truck, assaulted the female driver of the vehicle and told her child that was in the vehicle, 'I'm going to rape your mommy."

Multiple citizens heard the victim screaming and came to her aid, and one of those citizens was armed with his 9mm handgun.

The armed Good Samaritan approached Dailey and gave commands, but Dailey charged and shoved the man to the ground.

Dailey continued approaching the armed citizen, and that was when the citizen shot the suspect, hitting him in the chest.

Law enforcement responded after hearing the gunshot at approximately 1:15 p.m. while working a nearby separate incident on Mudfork Road.

Dailey was airlifted to Roanoke for his injuries with the last word on his condition being "stable.

Chicago mom pops perv crawling into daughter's bedroom, cops take gun

Duo becomes a solo

Chicago woman and her gun repels pair of home invaders

Chicago (WGN9) — A home invasion suspect was shot and killed Wednesday morning on the West Side by a woman.

Officers responded to a home in the 700 block of North Laramie just after 6:40 a.m. on the report of a shooting.

Police believe two suspects forced their way into the home and displayed firearms.

A 23-year-old woman in the home, who has a valid FOID card, produced a firearm and there was an exchange of gunfire.

One of the suspects, an unidentified male, was shot in the chest. He was pronounced dead at Mt. Sinai.



PRO-TIP: You can't shoot trespassers without a threat of death or great bodily injury...

(GSL) - A whole lot of people have gross misconceptions on how much latitude they have to legally threaten or use deadly force against trespassers. An AP story from outside of Denver delivers a bevy of lessons for gun owners nationwide about how those misconceptions can land you in prison.

The Colorado case begins with a teen looking for a spot on a lake to take picturesque photos for homecoming. The young man hopped a fence to knock on the front door to ask for permission. Finding nobody home, he returned to his truck with his buddy to write a note. While they wrote, the property owner's boyfriend rolled up, raised a shotgun at the pair in the pickup and fired through the windshield.

The trigger man claims it was an unintended discharge, but that's not going to save his bacon.

The homecoming photo seeker was seriously injured and the property owner's boyfriend got a free tour of the county jail and felony charges. As he should.

Lessons we can all learn:

1. Just because you have a trespasser doesn't mean you can brandish your gun without a darn good, legally justified reason. You can't even blast a trespasser *inside your home* unless you can articulate a threat of death or great bodily injury from the trespasser. Yes, you get a lot of latitude from the law inside the

home, but absent weapons or a violent and tumultuous entry into your home, you're on thin ice if you shoot someone just because they're standing in your living room empty-handed. Shooting an unarmed person in your back yard? Pack your soap on a rope, son.

- 2. Why would you escalate a trespassing issue into a gun battle? You could lose the gunfight or become permanently disabled. Is wearing a colostomy bag for the rest of your life worth telling someone to get off your lawn?
- 3. Even if the trespassing issue turns into a burglary of your tool shed or garage, stay in your house. Sure, you might go out and confront them, and it might escalate into a gun battle. How will it look to a jury that you shot some kid over an old Craftsman lawn mower especially jurors who don't like guns. (And again, you might get shot yourself.)
- 4. In this case, it seems Mr. Hotshot pointed the gun at two unarmed teens that weren't even on the property and shot. Yeah, he's going to prison and rightly so. What he did was above and beyond the call of brains.
- 5. Trespassers on your property (or your neighbors' property)? Stay inside and out-of-sight. Let your fingers do the 911 dance and let the police sort things out. If they don't show up in time, fine. Give them a description of the vehicle and its license plate.





Reloading: Is it right for you?

by Damon Williams (GSL) - I have always been amused at the old reloader's adage, "Reloading doesn't save you money, it just allows you to shoot a lot more ammunition."

If you are considering dipping your toe into reloading, you should dispassionately evaluate if reloading makes sense in your shooting practices. Are you a casual shooter, hunter or plinker? Do you have limited time (or space) in your personal life at home? Do you run through less than a case or two of ammunition in a year? Are you on a tight budget? How old are you - aka how many years of trigger pulling for adventure and recreation do you have left?

Or do you have time and money to train relentlessly for defense or competitive matches? Do you have concerns about the availability of ammunition due to gun control schemes coming to Illinois? Perhaps you have obscure, hard-to-find calibers and/or obsolete calibers? Embracing reloading and building an inventory of components on-hand allows you to keep feeding your hobby no matter what laws the commies pass. Brewing your own will also allow you to feed your cherished hog-leg/

What you need...

Ask six reloaders for advice as to what reloading equipment, or kit, will best suit your needs, and I assure you that you will get at least eight different answers. I warn you that brand loyalty runs strong in the reloading community, which will greatly influence the advice that you are given.

I believe that reloading is an acquired skill. Sure, there are plenty of horror stories out there about someone's reloads blowing up and causing damage and injury. But take it from a guy who has

had the inside track in dealing with a major ammunition manufacturer, the mechanical process is the same whether it be a high speed precision custom engineered production machine, or a single stage press in a basement on a workbench made from discarded pallets. The key is pay attention to what you're doing and use <u>published load</u> data!

"But I don't have a mentor to teach me." This was my excuse for several years until my shooting tempo forced me to a more budget friendly practice. So, I sat down and learned from a book; Modern Reloading by Richard Lee. The 700-page text is everything that you need to know about handgun, rifle, and shotshell reloading. The first 200 pages is the information and training narrative, the last 500 pages is all load data. There are other books out there, this is just the one I read, and I recommend it.

Like with shooters using their guns, reloaders need to learn to walk before they run. A single stage or turret press where one action is performed at a time is an important part of the learning curve. It is also about learning muscle memory. In order to achieve the rated roundsper-hour the manufacturers advertise, you need to find a rhythm keeping both hands moving at the same time. One also must acquire a physical feel for each operation of the press for maintenance and troubleshooting comprehension.

One more thing about rounds-per-hour, while the manufacturers numbers are optimistic, they are mostly realistic. However, they do not take into consideration preparation and layout of components which can take 20 to 40 minutes prior to stroking the first rounds from the press.

These single-round press kits are a great beginning platform. When I started with a single stage press, I could load about 75 rounds per hour. Graduating to a turret press, my production grew to about 200 rounds per hour.

The reason I emphasize these setups to beginners is that only one case is loaded at a time and the operator has greater quality control when monitoring one cartridge at a time. This is also where the muscle memory develops.

On the other hand, so-called "progressive" machines have three, four, or five cartridges going at a time. It takes an advanced understanding to monitor multiple rounds in various stages of the process to identify a problem when the machine doesn't "feel right". I own a progressive, but still prefer to use my turret press.

Here's another positive: Reloading equipment retains much of its value. If you later find that you want to upgrade to load on a faster machine, you can sell your old equipment and recover much of what you have in it. (And if you're a beginner, you can buy used and save a few bucks).

Take a look at *eBay*, some are asking new retail prices for used equipment. Shop around - including online shops selling new products. Another tip: if you pick up a Dillon product, they will rehab an old unit for just a few bucks and they replace broken parts for free.

Over the next few months, I want to run the numbers for you addressing the cost-benefit analysis of reloading handgun, rifle, and shot-shells. You'll be surprised, the numbers will show that it's not for everybody.

So you made the decision to buy your first gun

by Byron Shanks You finally made the decision. For several years you have worked around in your garage workshop trying to make nice things for your family. Nothing came out the way you wanted because it takes time to master any skill. Today you brought home your newest purchase - a nice power miter box. After unboxing it, you set it up in a corner and try it out. It feels good to run something so precise. Still, the results are not as good as you had

You realize that the saw is not the problem. Your measurements are not all that

So you take more time and read the tape more carefully. Your lines are not as messy and fat as they used to be.

Over time, the parts fit together better, but you know they are still not what you are looking for. You realize that there are different saw blades to fit the saw and you experiment till you find one that gives the best results - the cleanest cuts with the least amount of tear out. But there is something else as

The more you use the saw, the more you realize that you are the one responsible for

controlling it. When you first started out, you were lucky to get within an 1/8 inch of the line. Now, after lots of practice, you can leave just the smallest bit of the line.

Not only that, but you figured out how to cut crown molding on the saw. Once again, it took time and practice to get the results you wanted, but they get better all the time. It doesn't require that you spend hours every day in the shop, but that you spend time regularly and that you study to see how you can improve.

You are not sure you will ever reach perfection, but you have to admit that it is satisfying to see that you have made real progress.

The saw has not changed. You have. You have spent time working at improving your part of the process. It is not just pulling the trigger on the saw. It involves alignment so that the saw cuts where you want it. It involves making sure that the blade and the saw are in top shape. It involves you paying attention and not accepting the "good enough" attitude. Now when you make the parts, you smile. You have a confidence that you can make the saw do what you want it to.

What does all this have to do with guns?

The same lessons learned with the saw are the same lessons that must be learned with the new firearm you just

You will not gain the confidence and performance that you want by simply buying the gun and leaving it in the dresser drawer. You won't improve if you put hundreds of rounds through it in one day and then not touch it for months. The age-old formula of time and practice is the best method to obtain the best results.

It also helps to develop friendships with people that have learned before you. Keep at it and you may be surprised when you find yourself smiling at the perforated target after a day at the range. Maybe when you are not in the garage together, you and you kid might want to enjoy the range time as




