Our lawsuit wins at federal district court; PICA gun ban ruled unconstitutional Donald Trump won his race for President; pro-gun nominations everywhere

(GSL) - It took 18 long months but we won our lawsuit challenging Governor JB Pritzker's beloved gun and magazine ban in federal court. We joined our friends at Firearms Licensees of Illinois, the Aurora Sportsman's Club, Gun Owners of America and others in the suit.

Unfortunately, federal court judge Stephen McGlynn issued a 30-day stay on his decision to allow time for the State of Illinois to appeal. And IL Attorney General Kwame's crew did appeal it within roughly an hour of its release. In other words, they expected to lose.

One of the two judges who ruled against us last fall at the preliminary injunction phase of the case has retired. Her slot on that three-judge panel will be filled at random. Given how the Seventh Circuit Court of Appeals panel is pretty much evenly split between those who follow court precedent and the rule of law and those who hate guns, we stand a

50/50 chance of getting a good assignment. Meaning if we get a "rule of law" judge assigned, it's far from a sure bet that McGlynn's preliminary stay will be extended.



The decision came down just days after Donald Trump soundly defeated Kamala Harris. Harris liked to say "We're not going back" at her rallies, but Americans decided they preferred to go back to peace and prosperity.

With Trump's election and the Republicans taking control of both the US House and Senate, Trump will have an opportunity to unwind the Biden/Harris policies in short order. He's picked some stellar nominations for administration officials who will get things done. Most are very pro-gun. Few are Beltway insiders.

Even better, we look forward to Trump's solidly pro-gun nominees to the US Supreme Court, as well as the lower federal courts over the next four years.

As if that's not winning enough, there's little doubt that Vice-President JD Vance will make a very strong candidate for President in 2028. Unlike under a Harris administration, gun owners will have an opportunity to build upon the bulwark of the US Supreme Court to ensure our gun rights are protected, not eroded, for generations to come no matter who wins in future elections.



Greg Bishop dazzles in Decatur

(GSL) - Guns Save Life welcomed a real journalist to our Decatur meeting as our main speaker. Greg Bishop, an editor with The Center Square news outlet as well as host of a growing daily political blog on America's Talking Network currently on You-Tube. He shared his background and his present day job offering unbiased reporting on political issues that the public desperately wants.

He began his presentation praising Guns Save Life's monthly publication GunNews. "This is the epitome of the First and Second Amendments combined," he said. He added that Guns Save Life, as an organization you can trust, is something gun owners should all support. Moreover, there are precious few news publications that offer a pro-firearms rights perspective.

In this world of legacy media outlets which are basically staffed by Democrat operatives with bylines, Bishop described himself as a member of the "free press." He didn't go to "J-School" - journalism school. Instead, he parlayed a communication degree into honest work for independent news media after getting his start in radio. Today, his audience and readership has grown by leaps and bounds, horning in on some territory formerly controlled by the mainstream media that works to propagandize the public with the narrative of the day.

"The public is thirsty for reliable, trustworthy information," Bishop noted. And that's what has allowed The Center Square to grow and flourish and now America's Talking Network of podcast shows that's right on the cutting edge of what people want.

He's developed a reputation for asking tough questions, especially of our state's political leaders. Those pols especially JB Pritzker - don't like that.

He closed by asking folks to support news organizations that you find are honest and trustworthy. You don't need a paid subscription to read *The* Center Square or to watch America's Talking Network videos, but donations help pay the bills and the staff. As such those donations are certainly encouraged. At the very least, bookmark The Center Square website and subscribe to America's Talking Network YouTube page. That will help both with traffic and provide you invaluable information.

Natalia was back - and class was in session!

(GSL) - Former prosecutor and now criminal defense attorney Natalia Ogurkiewicz returned to Central Illinois to address our audience at SCHEELS in Springfield.

She's been there before, teaching folks how to avoid becoming a victim of the criminal justice system after using force in self-defense.

She works for the McDermott Law Group which specializes in criminal defense cases involving selfdefense. They work these cases nationally and have a reputation for, well, not losing. They are affiliated with US Concealed Carry Association, although they'll take cash (retainers start around \$30-40k - and that doesn't cover the trial retainer) or other self-defense legal coverage like Armed Citizens Legal Defense Network.

Recapping her earlier visit, she strongly recommends not saying anything to responding officers or investigating officers. Instead, wait until you've talked with your attornev.

"STFU," she says. Shut the heck up. "They will twist anything you've said," she explained of your statements immediately after a use-offorce incident - and that includes "how" you said what you said even

on a 911 call. Were you mad? Angry? Vengeful? Flippant? Take most of that away by keeping your words to the absolute minimum. When it comes to the police, say NOTHING after asking to speak to your attorney.

On this night, she reviewed cases and how despite righteous claims of self-defense, how some who used their guns in self-defense now find themselves in lockup until trial.

One was a road rage case on I-55 in DuPage County. You thought DuPage was a law-and-order county? Think again. A man fired a shot at pickup truck trying to run him off the road. He's now in jail charged with serious crimes.

Another case involved a 54-yearold woman who shot a 30-year-old man who attacked her and the rest of her entire family at an elevator

at the hotel. She's charged with

"You don't get anywhere giving info to police," Natalia warned the audience. So shut up.

The audience threw some really good questions at her. Asked about warning shots, she said, "it depends." At least from a legal perspective it's high risk.

What do prosecutors look for in deciding whether or not to charge cases? First up, it's the context of the incident. Did the "good guy" exhibit shady behavior or escalate conflict?

Secondly, and this is a big one: What are the headlines going to look like?

She closed by noting that criminals don't just stay in "poor" neighborhoods. They often like to travel to where the money is - places where productive folks live, work and shop. "This is why who you have for a State's Attorney is really important.

What else is important? Have USCCA or some legal defense coverage so you don't bankrupt yourself if you find yourself charged by a headline-driven prosecutor.

Governor is no superhero, acting more like a tyrant at times

Pritzker appoints himself democracy's savior

by Mark Glennon (WirePoints) - It would be comically hypocritical if weren't so tragically destructive. Illinois governor JB Pritzker last week appointed himself co-chair of a new group to save democracy.

It's called Governors Safeguarding Democracy, formed to counter the incoming Trump Administration and Republican Congress. "What we're doing is pushing back against increasing threats of autocracy and fortifying the institutions of democracy that our country and our states depend upon," Pritzker said of the effort. "I've said it once, and I'll say it again: No attempts to restrict the freedoms and opportunities of Illinoisans will be tolerated.

No governor in memory in any state has thumbed his nose at democratic norms and constitutional rights more consistently and flagrantly than has Pritzker...

Through 43 consecutive, monthly emergency orders, he suspended ordinary government function and ruled by executive fiat, trampling on a list of

constitutional rights, justified through censorship and suppression of opposing scientific views. Similarly, he issued 38 consecutive emergency orders enforcing his personal decisions about assistance and protection for illegal immigrants.

- He says he wants there to be a legal cause of action against anybody who says something false, which would be a flagrant violation of established First Amendment law.
- He has signed off on multiple policies and bills that violate constitutional rights to free speech, such as Illinois' new law banning discussion of political or religious matters at company meetings, now being challenged in federal court. Another example is a Pritzker-signed law attempting to muzzle pro-lifers that was ridiculed by a federal court as "stupid" as well as unconstitutional, prompting Attorney General Kwame Raoul to give up trying to defend the law.
- He stood aside while his party's operatives filed lawsuits to keep Donald Trump and Robert F. Kennedy, Jr. off the ballot for the presidential election.
- Even the Democratically slanted Illinois courts couldn't accept a law Pritzker signed earlier this year attempting to knock only Republican candidates off the ballot through a retroactive change in slating procedures. The Illinois Supreme Court in August upheld a lower court ruling that the law flatly violated the constitutional right to vote.

[Editor's note: You mean restrict freedoms like those Pritzker signed into law banning commonly used defensive firearms, including America's favorite rifle, the AR-15 and the magazines that feed them? You mean those attempts, Governor Jelly Bean?]



Chicago (Breitbart) - The Chicago Police Department reported having arrested [dozens of] members of the dangerous Tren de Aragua Venezuelan street gang, only to find the courts releasing many of them right back out onto the streets.

Dozens of these gang members have been arrested over the last two years for an array of offenses, including drug dealing, human trafficking, gun charges, theft, and other charges, the New York Post reported.

However, thanks to the recent state-wide implementation of the SAFE-T Act, which eliminated cash bail in most cases, many of these gang members were released right after being arrested...

Mayor Brandon Johnson's largest campaign contributor behind CTU nabbed by feds for conspiracy to commit murder

Chicago (CBS) — Grammy-winning Chicago rapper Lil Durk has been charged in a murder-for-hire plot and is now in custody.

The FBI said the Englewood neighborhood native was arrested Thursday night in South Florida as he attempted to flee the country.

AMERICA WINS

Lil Durk — the stage name of Durk Devontay Banks of Chicago — was arrested in Broward County, Florida. Investigators believe he targeted rapper Quando Rondo.

Rondo was the intended target of a 2022 shooting in which gunfire missed him, but killed his cousin, 24-year-old Saviay'a Robinson.

The arrest came hours after five people associated with Lil Durk's music business were also accused in the case. Those other members of Durk's Chicago-based rap collective, "Only the Family" or "OTF," have also been arrested and at least two more arrests may be forthcoming, according to court documents that have been filed.



Comparing someone to Hitler shows a gross ignorance of history

When a Comparison Goes Badly

Over the last eight years or so, a major politician in our country has been compared to a now-dead dictator and mass murderer – responsible for the deaths of tens of millions of people. These person-to-person comparisons reveal more about the person making them, than the assertion itself, almost always revealing how little the person who uttered it knows of history. So, if you get your news from the good folks on The View, SNL, washed-up standup comics, or Morning Joe, let's get into some facts.

The two subjects in question are DJT and AH. You already know DJT and either like him or don't like him. So let's concentrate on AH. But first, let me provide the conclusion, so this is a spoiler alert. No American, living or dead, is comparable to AH. No Republican, no Democrat, no Whig, no Libertarian, no Green Party, no US Communist Party, no Symbionese Liberation Army member, no Black Panther Party, not even an adherent of the Know Nothing Party, has ever remotely been similar to AH.

But I digress. You already know that AH was born in 1889 in Germany, and if you believe that you are incorrect. He actually was born in the small town of Braunau am Inn, Austria that year. I know Braunau is right on the border with Germany, but you're either born in a country or you aren't. AH didn't move to Munich, Germany until 1913, in part to avoid arrest for evading his military service obligation to Habsburg, Austria. Then came The Great War, which we know today as World War I. He apparently changed his view about military service, joined a German army unit in Bavaria, fought primarily against the British, was wounded twice and received several awards for combat.

You probably know that AH was one of the founding members of the National Socialist Workers' Party (known as Nazi for short), attending his first meeting on September 12, 1919 in Munich. Actually it was the German Workers' Party then, but more importantly he attended the meeting not as a new member, but as a clandestine German Army confidential informant. Yes, he was a spy, tasked with gathering intelligence on political movements potentially hostile to the Bavarian authorities. But in maybe the most dramatic switcheroo in history, within a month, AH went back, joining the organization as the 555th member.

Over the next 14 years, AH

maneuvered his way into being the head of his party. started an uprising in Munich at a beer hall (but not the famous Hofbräuhaus as is often claimed), was arrested, spent time in prison and according to Wikipedia- that bastion of historical accuracy wrote his view of the world in his book "My Struggle," which you know as Mein Kampf. Actually, he dictated the book to a cellmate, but that's a minor historical inaccuracy. Years later, retired field marshal Paul von Hindenburg, who was now Germany's President, selected AH as Chancellor. Eighteen months later, AH ordered a series of political extra judicial executions within the Nazi Party intended to consolidate his power. No one knows for sure how many died - it could have been hundreds but what is known is that the event quickly became known as the "Night of the Long Knives," a phrase that even today is still used for any elimination of former associates from power.

The next year, Germany started the road to war marching into the Saarland in 1935, Austria in 1938, Suden-

tenland (now part of Czech Republic) later in 1938, Bohemia and Moravia (now parts of Czech Republic and Slovakian Republic) in 1939, Poland later in 1939, and then Belgium, Netherlands, France, Denmark, Norway, Yugoslavia, Greece, etc., etc., etc. The American, compared to AH, was in power for four years and invaded no countries.

AH would fit right in with a whole bunch of people today in his hatred of Jews. Of course, today's haters camouflage their views by cutesy, rhyming phrases such as "From the River to the Sea," while AH just said Judenfrei or Judenrein which meant a one-way train trip to Auschwitz. Treblinka - and you know what happened there. Our guy? Well, his son-in-law is Jewish. His daughter converted to Judaism, and my guess is that their three children, his grandchildren, are part of that religion. Outside the family, our guy moved the US Embassy in Israel to Jerusalem, after previous presidents - Republicans and Democrats - for seventy years had promised to do just that, but had never delivered.

And DJT never murdered one person, although at least one person tried to murder him, apparently with the blessings of quite a few. According to MSN (Microsoft Network), a poll taken by a Rasmussen affiliate indicated that 28% of people who identified as members of one political party thought the U.S. would be better off if one candidate for president had been successfully assassinated last July 13, 2024. Now, not even those folks compare to AH. But they certainly are "useful idiots," a phrase attributed to Bolshevik revolutionary Vladimir Lenin – a man who certainly was comparable to Adolf Hitler.

New OSHA Emergency Response Standards could shutter 80% of volunteer fire departments

(PJ Media) - The Occupational Safety and Health Administration (OSHA) is seeking final approval for a massive overhaul of the "Fire Brigade Standard" that's been in place for 50 years. The 608 pages of new rules, quite simply, would mean that about 80% of volunteer fire departments in the United States would be forced to cease operations.

"Over 85 percent of America's fire departments are either volunteer or mostly volunteer. Nearly 700,000 of America's 1,056,000 firefighters are volunteers or paid per call firefighters," a group of lawmakers, led by Sens. Jerry Moran (R-Kan.) and Christopher Coons (D-Del.) said in a statement. "The proposed rule would apply to more workers than the existing standard and would require fire departments to furnish new reports, trainings, equipment, and health services."...

Take training: the proposed regulations demand 80 hours of training for firefighters. For volunteers, that means two full weeks of work, squeezed in here and there, for no money.

"If I tell some of them younger guys that, 'Hey, you can't spend the night with your wife and kids. You got to go

to training tonight,' they might tell me to go pump sand," said Joel Cerny, chief of the Linwood, Nebraska, volunteer fire department...



Like most rural volunteer fire departments, the Natoma, Kansas, department uses old fire protection gear. Proposed OSHA rules could require Fire Chief Keith Koelling to replace it all with new gear every decade, costing tens of thousands of dollars.

This is what happens when you have a government run by coastal elites with little or no knowledge of how most of the country lives and works. OSHA will hold public hearings beginning this week on the impact of the new regs on small-town and rural volunteer fire departments.





Compare and Contrast:

Tales of two pairs of two great guns

(GSL) - Over a recent great day at the range (is there ever a bad day at the range?), I had the good fortune to compare and contrast two pairs of similar guns, back to back at the range.

Now, I'm all about defensive shooting, so this isn't about precision marksmanship or noise-making. This is about putting minute-of-bad guy rounds on target. Enjoy a couple of hot takes to help you decide if one or more of these guns are for you and your roster.

Taurus 856 Defender vs. the Rossi RP-63

I loved the old Taurus 85 clones of S&W J-frame 5-shot revolvers. Now, they come with six round capacity and are known as the 856s. Taurus has a subset known as the "Defender" series which includes night-sights: in this case a big, glowing front sight blade. I'm wearing one right now, running .38 +P 158 gr. semi-wad cutter hollow-points even though it will eat .357s.

Thanks to a rave review by a friend at Shooting News Weekly's blog, I picked up a Rossi RP-63 as my birthday present to myself. Taurus bought Rossi's name and the 63 is basically (but not exactly) a K-frame S&W with a 3" barrel just like the 856. Both guns feature triggers and actions are peers to modern production S&W revolvers in my experienced opinion... and you can have either the 856 Defender or the RP-63 for half the price or less of a Smith. As in \$375-400 out-the-door.

The difference between the 856 and the 63? No night sights on the 63, but then again none of my other wheelguns have them (yet). The action isn't quite the same between the two, with the 63 easily shooting 3" groups at 10 yards where the 856's were consistently tighter. Both are capable of sub 1" groups if you manage your trigger press carefully but the Taurus wins this aspect by a nose as well. (For the record, I also shot a "tuned" S&W this same day and a carefully managed trigger press netted a ragged one-hole group at 10-yards. Then again, that's a \$1200+ gun in today's world thanks to a Tom Kilhoffer's action job.)

However, that night sight on the Taurus 856 puts it head-and-shoulders above the new Rossi revolver (or almost *any* revolver without night sights), but both the Taurus and Rossi are *very* capable and competent defensive guns. Even better, both are affordable for those on a budget.

Ruger LCPMax vs. S&W Bodyguard 2

S&W's new Bodyguard 2 is like a 2/3rds size defensive pistol, only it packs the punch of a .380. I had the chance to shoot it against the Ruger LCP Max which I consider the finest deep-concealment / backup gun on the market at the moment. The Bodyguard 2 gave the champ a run for the money but didn't knock the Max off the perch. For many though, it might be a better choice.

Both guns come with night sights and hybrid double/single stack mags that hold 10 or 12 rounds of .380 caliber love. With XTP hollow point loads, the .380 consistently delivers about 12" of penetration which most consider ideal for man-stopping purposes. Other loads are hit or miss. Don't agonize too much over the brand of hollowpoint, just don't use way too over-penetrative ball rounds.

Both guns have excellent triggers right out of the box. Life's too short for lousy triggers.



Smith & Wesson's Bodyguard 2.

The Smith is just a little taller and longer but maybe a sliver thinner. Fair warning: The Smith might not fit in pockets that the LCP Max would snuggle into. At the same time the Bodyguard 2 has a *very* comfortable grip contour and will appeal big-time to those without bear-paws. Think petite women, younger shooters or those who just don't want the weight and bulk of a "full size" defensive pistol like a Glock on their hip.

Give it a few months and I think you'll be able to find plenty of inside-the-waistband holsters for the Bodyguard 2 to allow it to be carried in a primary defensive gun role for those extra sensitive to bulk, weight and printing. Yes, some people carry in non-permissive environments at work. A (formerly) hidden .380 in the hand beats the biggest, baddest .45 out in the car.

As an aside, does the Bodyguard 2 also give the Sig P365 in 380 a similar run for the money? They're also comparable in many ways: trigger, night sights, mag capacity, size. The 365 is also a tiny gun like the LCP Max so give it a try where you can rent guns. Also, for those with hand-strength issues, the P365 in 380 is definitely a good choice!

MICHAEL BOATMAN | Credits God, guns for his life today

American Preparedness: Some Further Considerations

by an Anonymous GSL member GunNews often has informative articles addressing preparedness. I found them generally clear, concise, thought provoking, and well written. I would like to supplement some of that information with some related topics for

Duration: Decide for yourself the likeliness of an emergency situation, and its duration. At the same time, if your finances don't allow you to prepare for that right now, start with getting supplies for a three-day emergency and build from there. Build your own custom plan based upon your type of residence, its location and your lifestyle. Preparing for an urban apartment dweller will differ greatly from a homeowner in a more rural area. *Hint:* There's no need to lay in a year's supply if your residence's integrity won't survive a bad disruption lasting more than a week or two.

Food: If you have looked at long term food storage from companies such as Wise and My Patriot Supply, long-term food is pricey and then some. You want a much more affordable alternative? The LDS (Mormon) Church has a network of locations in some major cities called Home Storage Centers (HSCs).

They sell #10 cans of dietary staples at grocery store prices. Most of their products have a 30-year shelf life. Additionally, the HSCs provide dietary and nutritional guides, suggested inventories, and even recipes.

While these facilities' primary purpose is to serve church members, they do sell to the public. The drawback: You'll have to travel to one of their facilities after making an appointment or visiting during very limited "open" hours. They don't accept cash or checks, just plastic. They do not ask if you are a church member; and they do not preach. You can find details by searching for Home Storage Centers LDS Church on-line. The closest ones near Illinois are in Naperville (Tuesday 6-8p, Sat by appointment) and Indianapolis (8-10:30a Tuesday, 10a-2p Saturdays). They urge you to call and confirm before making the trip.

Bonus time: In researching this story, I found that they have an online store. Yes, prices are about 10% more and you have to pay nominal shipping, but it saves you travel costs. Cases of #10 cans are still *very* affordable.

Spices: Look at your inventory of flavor enhancing spices and condiments. Make sure they're not expired

(they lose potency over time). Spices and condiments can make the difference between barely palatable and delicious. A tasty meal will lift your spirits, even if you are sitting in the dark with volcanic ash falling outside. It will also make your spouse, kids and other family members much happier.

Hygiene: We touch on medications regularly - have at least 30 days' on hand. Don't forget your hygiene. Good hygiene will help keep diseases at bay and help you remain positive. Body odor sucks. In short, make sure you've got the hygiene needs taken care of, including feminine hygiene stuff for the fairer sex

Water: The late Rush Limbaugh made a comical observation about a media story regarding preparation for a hurricane approaching landfall: The stores were sold out of bottled water.

Is there an impending disaster? Instead of (or in addition to) buying a bunch of water at the store, fill containers in your home. Water does have a shelf life but if you add a few drops of non-scented bleach and you'll have safe water with which to drink, wash and cook - all on the cheap. Not only that, but your water heater may have as much as 50 gallons of drinkable water. Access that through

the drain at the bottom. Sure, you may get some sediment at first, but you can filter that with a coffee filter.

Energy: Use your noggin. I once read a story about a generator owner who burned through \$400 in gasoline to save \$250 of meat.

In the aftermath of Hurricane Sandy, fist-fights broke out in the gasoline lines. Untreated gasoline has a short shelf life (hint: so treat it with PRI-G or Star-Tron and store it in tightly sealed containers!)

Remember, the drone of a generator carries a long way at night. It serves as a beacon for bad guys. Inverter generators cost more but they are lighter, run very quietly, deliver "clean" electricity and sip fuel compared to your dad's old, noisy generator.

Moreover, a refrigerator or freezer does not need constant power. Let it cool for a few hours each day, limit opening of the door, and you will maintain your food while conserving precious fuel.

Cooking: Please prepare for using wood, charcoal, or propane as backup cooking fuel.

Heat: It is our instinctual nature that a warm fire lifts the spirits, as will a warm

home in cold months. Do you have an alternative form of heat? Will it keep your pipes (and you) from freezing? If you decide on a kerosene or propane heater, a battery powered CO detector and fire extinguishers should be part of the plan. How about batteries? Have plenty


Weapons/Ammunition: Well, you are reading *GunNews...* We have just recently emerged from another ammo shortage. Did you learn your lesson? Another will happen. Buy now before it becomes scarce again - and at higher prices still.

Tools: Have basic hand tools. Also, have the materials you need to cover holes in your roof or broken doors/windows. This might include tarps, plastic sheeting, furring strips, 2x4s, nails or screws, and more. Maybe even a couple of sheets of plywood. You never know if you will need to make an emergency repair or fabricate essential equipment.

Keep it Quiet: Avoid trouble. The cold hungry masses, or even friends, cannot covet that which they do not know that you have. So don't blab and make sure your family members practice information discipline too. Loose lips sink ships.

Who wouldn't like to see deer, hogs, snapping turtles, lizards, turkeys and quail? And see fantastic sunrises in the morning as a testament to the creation God gave us as a token of His esteem? I saw turkey at virtually

every sit, and a lizard visited me in every



In my last sit I saw six does and a 4-pointer and 6-pointer. As a disciplined deer hunter I had to let them walk. That 6-pointer had good genetics and was chasing does. I've seen 6-pointers that didn't do that even during the rut, but this boy will be a nice 8-pointer next year, and if I don't take him next year maybe he'll be a 10-pointer the following year.

Disposing of Gun Collections

Mark Twain once famously noted that the only certainties in life are death and taxes. And in modern day Illinois, one can add increasing violent crime

While a few of us might escape violent crime victimization, we're all going to die someday - some of us sooner than others. Do your loved ones a big favor: help them identify and value your firearms collection before you die. Moreover, leave some guidance on what to do with those guns and accessories.

Sadly, many people don't know how to make guns safe, much less how to competently appraise values. Don't believe me? Each day, non-gun people "turn in" unwanted estate guns at police stations across America, either for virtue signalling or plain idiocy. Stupidity like this should hurt.

In Illinois, without a Firearms Owners ID card, those handling the estate have just sixty (60) days to either get a FOID card or dispose of all firearms and ammunition to comply with the law. So don't delay if you are the heir.

For those with a boatload of firearms there's an even greater urgency: security.

If people knew that "Roger Ruger" had hundreds, if not thousands of guns and they see his obit in the paper, his house just became a ripe target for burglary and/or a robbery/homicide. Mrs. "Ruger" will be no match for a halfdozen teenage doctoral students willing to kill for street cred and a bunch of "gats" to sell to fellow scholars. Or the black sheep nephew named "Hunter" and his crack addiction.

In those instances, getting the guns out of the residence is an over-riding concern. Have trusted family or friends look after the firearms until a decision is made on how to dispose of the collection. Or keep news of the death on the down-low. Even then, if there's a service, make sure there are at least a few well-armed and trusted family or friends at the house to prevent "obituary burglars" from pulling off a heist while the family is at the service.

WHILE YOU'RE ALIVE: Make a list.

First and foremost, make a list. And just like Santa, check it twice...

Include the make, model, serial number, approximate resale value, and any accessories that go with said firearm and their respective value as a package. Take pictures too. This also serves as your opportunity to earmark firearms to go to certain individuals as ap-

For those with just a few guns, it will be simple affair. For example:

Glock 19, 9mm with night sights. Ser. 046FJB. With about five spare Glock mags. Estimated value \$400 with the magazines. I'd like this to go to my son Mark.

For others, it may be more complex.

Ruger Precision Rifle. 6.5 Creedmoor caliber. Serial No. 12345A. Estimated value about \$800. With Vortex Razor 5-20x50 scope (attached and sighted in). Scope serial No. 6789X. Paid \$1700 for scope. Estimated

scope mount (\$100), Harris bipod (\$100), Timney trigger upgrade (\$200), three spare magazines and misc. accessories, as is, should bring at least \$2000, especially with the couple of hundred custom precision handloaded rounds of ammunition nearby in ammo cans. Don't part it out.



You could take five minutes to compile the above information for each gun now for your wife or kids. Or you could get hit by a bus before getting around to it.

Also, at least while the Protect Illinois Communities Act gun and magazine ban is still on the books, let your family know which guns, mags and parts are "regulated" and can't be legally (ahem) sold or given to just anyone. Along those lines, if you have anything illegal under state or federal law, you might give them a heads up as well. Unless you don't

This will protect your loves ones from some unscrupulous scumbag telling them how that custom Ruger Precision rifle is nothing special, cheating your beneficiaries out of hundreds if not thousands (or tens of thousands) of dollars. Or calling the cops and having the feds come seize the entire collection over a couple of war trophies.

Which scenario would you prefer?

Disposing of collections

Ideally, you'll have family to which you can pass down heirloom firearms and other pieces with sentimental value along with ammo and accessories. If you still have guns to liquidate, you have options.

In the old days you could put an ad in the paper. Not anymore. Selling guns individually should also be a no-go for safety unless potential buyers are well-known and vetted. Especially for collections of more than a few guns. Heck, people can't buy an iPhone these days without facing the risk of armed robbery.

One easy way to dispose of a few guns is to work with a local gun shop to put them on consignment. Local buyers might see them and if the gunshop is savvy they will list them through on online auction service like GunBro-

Yes, the gun shop will charge maybe 15-25% of the selling price for the service, but you

get the guns out of your house into a secure location right away. Not only that, but the gun shop will handle the paperwork.

Keep in mind that many gun shops don't want a whole lot to do with ammunition and accessories unless it's in pristine condition in unopened boxes.

Which brings us to another option: Auction houses. They will accept not only guns and accessories, but everything else from gun safes to reloading components and everything else gun-related. For larger collections, they'll even come get the stuff. For example, in Central Illinois, Bauer Auctions in Mattoon has massive, hybrid online/in-person gun auctions four or five times each year. [I highly recommend them and constantly hear rave

They will have experience at handling multihundred gun estates, so you won't overwhelm them with 100 or even 500 guns. (Have a thousand-plus guns? They may split it up over two or more sales so as not to oversaturate the market.) They typically charge a sliding scale fee depending on the sale price of the items, but it's usually under 20%. Now it may take a few months before there's an auction but about a month afterwards, they'll send you a check for the net proceeds

This will net you the most dollars for those guns and gear with a minimal amount of work on your end. The only downside is that it's not an immediate conversion to cash.

For high-end collections of collectibles, including guns that sell for mid- to high-four figures and beyond, I'd recommend the world-famous Rock Island Auction.

In a hurry? Yes, there's a way to do that as well. Call nearby gun shops and ask if they'll come out and make an offer for the entire collection. Expect them to offer about 40-50% of the street/retail price for guns in good shape, and less for poorer quality specimens. You get the money almost instantly, but you'll pay (dearly) for the urgency.

In conclusion...

In short, before you get hit by a bus, do your loved ones a big favor: inventory your guns and accessories, and include pricing information and recommendations on how to dispose of guns that aren't family heirlooms or sentimental.

And do your best to try to keep them out of the hands of idiots or woke social justice warriors who might turn them in to the local PD.

Big gun shows bring more than gun owners

Travelling with Guns: A Cautionary Tale

by Michael Keleher (GSL) - Well kids, last week my pal Don and I drove to Wannamaker's Tulsa Gun Show in Tulsa, OK. World's largest gun show. Five miles of tables and 70,000 attendees. The show was amazing.

What was not so amazing? The professional thieves who targeted our truck and many others with out-of-state plates the night before the show. Moreover, this wasn't a no-name, flea-bag dive we stayed it. This happened in a nice, higher-end hotel's parking lot.

Of course I blame my Adventure Wife for all of this. Before I left for the show, I showed her a metal pistol safe with aircraft cable I was taking along. She said "Oh a cable that can just be cut by bolt cutters. Good luck." It is obvious now looking back on it- she used her seventh level she-witch powers to summon denizens to attack our truck. Well about 8AM the next morning, I came out and opened the driver's side rear door and noticed an awful lot of light coming in through the passenger side rear window...and shattered glass all across the backseat and floor. The burglars cut off the padlocks and cables securing the empty pistol boxes and took them. I found the keys to one box on the pavement. Good luck with that empty open box fellas. They also had worked the releases to get under and behind the back seats to access some hidden cubby holes I did not know were there. These guys were quite good at this. If they had broken out the back window an alarm would have gone off. They had the tools, experience and nerve to thoroughly wipe out a truck parked underneath hotel cameras.

side of the vehicle I found the mutts had also taken the time and effort to pry open one side of the metal slat box cover and peel it completely over to the opposite side where it was left hanging off the right side of the truck. This was quite a feat. I imagine they wanted in after getting the two pistol safes from the cab- and they were rewarded with the sight of the gun cabinet. Said they had a lot of reports to type up already from the Holiday Inn, and we could just file the report online with ulsa PD. I got the hint.

When you are tired and just off the road bring your situational awareness up. You are not safe yet. Put the effort in to emptying out your vehicle and don't put it off until "later." I have been guilty of this many times while on long trips for shooting competitions. I don't like parading gun bags in through the lobby but am real diligent about it the first couple of nights. By the third night it generally gets chitted off to "Ahhh, nothing's gonna happen here." Well it can.

Don't know if we are going back to the Tulsa show. Certainly won't be staying in Tulsa if we do. We have discussed different vehicles with a trunk and having vigilantes taking turns on watch in the vehicle (would not need two rooms then just one!).



I have also been looking on line about getting some of those Apple Air Tag tracker chips-seem like a nifty and inexpensive thing to take travelling with you... and does anybody know where I can get in touch with that Chevy dealership that has the Trunk Monkey? I think we could reach an adequate financial deal to rent a Trunk Monkey for the weekend.

North Haven, CT (WTNH) — A man was arrested after threatening someone with a knife in a parking lot on Thursday, police

Police said at around 11:35 a.m., Obadiah Claud, 45, charged the victim with a knife and the victim took out his legally possessed gun to try to stop the attack.

Claud fled in his car when the victim took out the gun, police said.

Violent home invader shot dead in Champaign, IL

Champaign, IL (GSL) - Emmanuel Becerril-Perez, of Urbana, suffered a sudden and profound error in victim selection after he forced entry on a home in the 1200 block of Harrington Drive in Champaign. The attack happened in the pre-dawn hours of Sunday, November 10th.

Desmond White, 32, who is on parole, remains hospitalized tonight as he recovers from at least five gunshot wounds he received in the altercation early Sunday.

Good Samaritan caps high school football star shooting up party

Ft. Wayne, IN (WPTA) - Willie Ivy III's dad says he was a great kid-charismatic, a smart student, and a talented football player. His father and aunt say his future was briaht.

But on Saturday, the 17-year-old North Side High School student was fatally shot at a high school party that left nine others

"Losing a child to gun violence is the worst feeling ever," lvy Jr. said. "I'm just very overwhelmed.'

Editor: Turns out the so-called "gun violence" was instigated by Willie Ivy III himself. He pulled out an illegal gun and started shooting at the party. Nine people were either shot or otherwise injured.

A good Samaritan at the party also had a gun and shot and killed the 17-year-old Ivy before he could wound or kill additional innocents.

GSL CALLED IT: FBI quietly updated crime data: crime actually increased 4.5% instead of a 2.1% decline

(FoxNews) - The Federal Bureau of Investigation quietly updated its 2022 crime data to show an increase in violent crimes, despite previous data showing violent crimes had fallen that year, which was touted as a victory for the Biden-Harris administration.



GSL's GunNews headline story from September's issue (published in August): Don't believe the hype and 'misinformation' - Violent crime has surged under Biden/Harris.

"For some reason, the media, they did pick the crime data that they think goes and makes the Democrats look as good as possible. And then even when the crime data that they've relied on turns out by the very source of that data to be wrong, none of them fix it," John Lott, the founder and president of the Crime Prevention Research Center, told Fox News Digital in a Zoom interview this week.

The FBI released its annual crime in the

nation data for 2022 last year, which found a 2.1% decrease in violent crimes compared to 2021, Lott explained. The data was lauded by Democrats and the media as part of a turning point for crime woes in the U.S., following the crime wave of 2020, when defund-the-police protests and riots swept the nation and the pandemic's stayat-home orders upended daily life.

"To give people an idea of the size of the change, when the 2022 data came out in September 2023, they initially reported that violent crime had fallen by 2.1% in 2022... That's the final data, supposedly, for 2022. The revision of that final data that came out last month, now claims that rather than the 2.1% drop, that there was actually a 4.5% increase in violent crime that occurred in 2022. That's a 6.6 percentage point change there," Lott told Fox News Digital.

"It's from a drop to an increase. And, you know, the bizarre thing to me is, for a year after the 2022 data was put out, we were having headlines, news articles after news articles saying, 'Violent crime is falling, people mistakenly or erroneously believe that it's increasing.' And, you know, and they were relying on this data. But you don't see any corrections in the news. Saying, 'Oops, the FBI data that we relied on was wrong, that rather than a drop, there was actually an increase that had occurred," he added.








Doubling down on stupid...

Despite 'devastating' election losses, gun ban groups vow to continue their jihad against *your* gun rights

(TTAG - edited) - With gun owners pushing former President Donald Trump over the top in last week's election, gun-ban organizations, still reeling from the loss, are promising to work harder than ever to force more gun control on lawful American gun owners.

With Trump winning the presidency and Republicans retaking the majority in the U.S. Senate, gun-banners, accustomed to a Democrat Senate and President Joe Biden in charge, have been put in a quandary. With the overwhelming majority of Americans who support strong gun safety laws behind us, we will win."

Of course, if the majority of Americans had supported the group's agenda, Trump would likely not have been reelected. But I digress.

So-called Everytown for Gun Safety, which called the election results "devastating," also took to X to vow their continued battle for further infringements.

"Make no mistake: Trump's extremist agenda is a danger for our nation, but it means we'll double down on our efforts to protect our communities and continue to make progress, just like we did in 2016," the group posted. "The momentum of the gun safety movement can't be stopped. Gun violence isn't a left or right issue, it's a life-or-death issue. We can and will overcome this—together."

Not to miss a chance to bolster its coffers, however, Everytown used the loss of the White House to try to raise funds from supporters—a scheme likely spawned by their boss, Michael Bloomberg, spending millions on the election in an attempt to get anti-gun candidates elected.



Of course, the anti-gun group Brady, formerly Handgun Control Inc. until it decided to hide its true agenda by changing its name, also got in on the action.

"The election of Donald Trump is deeply troubling for our safety and freedom from gun violence," Brady President Kris Brown said in a released statement. "And that's why we are doubling down on our work and fighting harder than ever.

"So even though we won't have a friend in the White House, Brady isn't giving up an inch."

In a long, rambling statement on the Giffords website, former Congresswoman Gabby Giffords tried to make the election results seem to be about anything but guns.

"Now is the time for taking a stand—together—against division, against hatred and against the erosion of truth," she said. "And to women everywhere: I won't rest until every one of our rights and freedoms has been restored."

Interestingly, she did not mention any efforts she would make to help restore the Second Amendment rights of those "women everywhere" she claimed to be addressing.

Reloading cost-benefit analysis: Rifle cartridges

(GSL) - Last month, we looked at the financial benefit of pistol caliber reloading. The numbers showed that in the current market, reloading of 9mm is not worth one's effort when compared to time and components. .45 ACP was worth the investment, allowing you to shoot about twice as much of that caliber as compared to retail, and .44 Magnum was definitely worth the investment with the cost of the equipment paying for itself within the first few hundred rounds. Your cost savings will vary with other calibers.



To my surprise, the latest issue of the Dillon Precision's *Blue Press* featured an article by Alan M. Rice titled *Reloading ROI*. Mr. Rice ran an analysis similar to mine only for "match grade" ammunition. He failed to include the cost of the reloading equipment as I've been doing. Rice's piece is a good read, but let's face it though: he wrote that for a publication that sells some of the finest reloading equipment available.

So, this month, let's look at the cost of reloading of three common rifle cartridges: .223, .308 and .45-70.

We will also use the same parameters as handgun rounds with your **time** valued at \$15.00/hour (or \$.25/round at 60 rounds per hour) and **primers** will set you back about \$80/1000.

Powder: Let's use Accurate 5744, a versatile powder that will load all three well enough to compete in a 3-Gun match or put meat on your table. The cost here is about one cent per grain (or \$70 for the one-pound - 7000 grain can). .45/70 and .308 each take about 30 grains and .223 half that.



Equipment. Unlike pistol reloading, rifle cartridges have a significantly larger surface area and require much greater amounts of pressure to re-size. As such, I am going to forego the progressive machines and recommend a single stage press kit. This is going to slow our progress to an optimistic 60 rounds/hour. Again, the best value that I have found is the Lee Breech Lock Challenger Kit for \$190. And again, this is a ready to use kit minus dies. Lee brand dies (best value I found) run \$35. But wait, unlike pistol brass, rifle brass is much more susceptible

to stretching after firing and resizing. An additional consideration needs to be made which is trimming; Lee Quick Trim \$25 and the caliber specific trimmer die \$14. Also, unlike pistol reloading you will need to lube your cases. My favorite product is Hornady One-Shot aerosol spray. \$12. All told, \$276.

Brass: Let's look at brass depreciation. Again, assuming you get six loadings before you need fresh brass. .45-70 cases run about .40 each, or about 7 cents per load. .308 is a little cheaper at 4 cents and .223? It can often be found just laying around on busy ranges or the streets of Chicago free for the taking. Your mileage may vary.

Bullets (projectiles for the newbies): My research has yielded me these average prices: .45-70 405 grain lead: \$0.30 each .308 150 grain FMJ: \$0.25 each .223 55 grain FMJ: \$0.16 each

So, let's run the numbers:

- .45-70: Roughly \$20.00/20 round box in your input costs or \$1 per round. Compare to an average of \$25-40 retail.
- .308: \$18.40/box to reload. Compare to an average of \$15-25 retail.
- .223: \$13.20/box for homebrew. Compare to \$6-10 retail.

Unlike Mr. Rice who didn't factor in the equipment costs, let's divide our equipment costs (\$276ish) into the first 500 rounds of ammunition - or about \$11/box of 20 rounds for those first twenty-five boxes.

- .45-70: Even factoring in the equipment costs, \$31/box to reload your .45-70 rounds is competitive with the most affordable commercial loads. After that first 25 boxes (and that's a lot of shooting with that old cartridge), it goes back to \$20 per box, or about a buck a round. That's marginally cheaper than buying commercial.
- 308: Paying for the gear brings the cost up to about \$30 per 20 rounds, or well over retail for commercial loads, especially with some of the more affordable offerings as low as \$15-20/box. But after 500 rounds, your out-of-pocket costs fall under a buck a round, or roughly commercial cost
- .223: The price of your reloading stuff drives the price up to as much as four times retail. Even after you pay for the reloading equipment, it'll still cost you at double that of the cheap commercial stuff (when ordered in case lots where shipping is often free) to reload.

Final thoughts: What numbers do not tell you is reloading is a hobby, a pastime, unto itself. It allows you to customize your loads to your preference. It allows you the peace of mind knowing that your preferred load is just a few dozen lever pulls away at any time of your choosing, verses waiting for the next shipment to come into your local retailer or waiting for a shipment to come to your door.

At the same time, there's no muss, no fuss and no lost bench and shelf space if you just order your ammo and have the boys in brown deliver it to your door in a couple of days. For mega-popular calibers like 9mm and .223, you're money and time ahead just ordering online or picking up sales at your local gun shop. For less popular calibers, reloading may be your cost effective - or only option for the more obscure stuff.

One, many, who were in the past victimized by government bullies and cowardly bureaucratic grandees, or proved sharp critics of the administrative state, are now, in karma-style, in charge of the very agencies that hounded

So, Elon Musk, perennial target of government regulatory functionaries, was once policed, but now he polices the bureaucratic

Robert Kennedy, Jr., proposed overseer of government health programs, was often blasted as a crank by the subsidized scientists and the administrators within HHS whom he will now direct.

Pete Hegseth fought the military DEI machinery while a solider in the ranks and wrote a book about the corruption of the Pentagon. He will now, if confirmed, run the Pentagon.

Two, none of these appointments are traditional swamp creatures. Few rotate from the think tanks. This time around there are no retired "Wise Men" or retired four-stars.
